CUSTOM EARLY LEARNING

Custom Early Learning programs are available year round or for the school year. Early Learning Tuition is based on the total cost of the full school year rather than the number of attendance days in a month. The total tuition fee of selected program is divided into equal monthly installments for consistency and convenience.

Please note that we have two Payment Plan Years at the Early Learning on Cedar

- September 1 to August 31 for full-year plan
- September 1 to June 30 for school-year plan
- 12 month plans available only to full-year Early Learning or families with other students in the traditional K-12 programs.
- If you have both an Early Learning student and a Traditional K-12th grade student on the same tuition plan, your
 payment plan will run from August through July.

Plans renew every year in the fall regardless of initial enrollment date. Please be watching for communication each spring for re-enrollment to secure your child's place in their class.

Infants will remain billed at the infant monthly tuition rate until they are 12 months old, walking, and a spot becomes available in the next age group. At that point, your payment plan will be updated to the monthly rate for the older age group.

All tuition plan payments are managed through FACTS Tuition Management through either direct debit from your bank account or an auto charge to your credit/debit card with an additional 2.95% processing fee.

Please see FACTS annual fees associated with each plan.

Payment options are:

- Payment in full by May 1st receive a 2% discount on tuition. (FACTS annual fee \$25)
- Payment in full by August 1st. (FACTS annual fee \$25)
- Semi-annually, two payments September and January. (FACTS annual fee \$55)
- Payments may be paid monthly. (FACTS annual fee \$55)
 - Tuition for full-year plans run September-August.
 - Tuition for school-year plans run September-June.
- If you have **both** an Early Learning student and a Traditional K-12th grade student, your early learning payment plan will match your Traditional K-12th grade payment plan.

NWCS applies a \$50 late payment fee for all returned payments, in addition to any FACTS and/or bank fees.

Preschool Withdrawal Procedure:

Notice Requirement:

- Families are required to provide **at least 14 calendar days' written notice** prior to withdrawing their child from the preschool.
- To officially withdraw a student, both parents or legal guardians must complete, sign, and submit an Intent to
 Withdraw Form to the Business Office at businessoffice@nwcs.org. A student will not be considered withdrawn until this
 process is fully completed.

Billing Policy:

- Tuition is billed in half-month increments, regardless of the date of withdrawal.
- If the withdrawal notice period overlaps with the start of a new half-month billing cycle, tuition for that cycle will still be charged.

Final Tuition Payment:

 Tuition for the final billing period will be adjusted based on the child's last day of attendance and the 14-day notice requirement.

Example Scenarios:

- If a family provides notice on January 1, the withdrawal date would be January 15 (14 days later). Tuition would be billed for the first half of January.
- If notice is provided on January 10, the withdrawal date would be January 24. Tuition would be billed for the second
 half of January.
